The "One Big Beautiful Bill" that Congress is working on is certainly big, but beauty is in the eye of the beholder. Too often the reality of these budget debates gets obscured in details, politically charged issues and demagoguery. Let me attempt to clarify the current discussion by focusing on the most important facts and numbers.

In fiscal 2019, federal outlays totaled \$4.45 trillion, or 20.6% of gross domestic product. This year, according to the Congressional Budget Office's January 2025 projection, total outlays will be \$7.03 trillion, or 23.3% of GDP. That's a 58% increase over six years. The CBO projects federal outlays will total \$89.3 trillion across fiscal 2026-35. Much of the blame goes to pandemic spending, but lockdowns are long over. There's nothing now to justify this abnormal level of government spending. Pathetically, Congress is having a hard time agreeing on a reduction of even \$1.5 trillion from that 10-year amount. That's a 1.68% cut—a little more than a rounding error. My guess is that much of that minuscule decrease will be backloaded to the end of the 10 years for which Congress is now budgeting, increasing the probability those savings will never be realized.

Other than during World War II, the increase in spending we've experienced over the past six years is unprecedented. After the war, Congress and President Truman understood the importance of returning spending to normal levels. In 1941, total outlays were \$13.7 billion, or 11.7% of GDP. They peaked in 1945 at \$92.7 billion, or 41% of GDP. That was a 577% increase, 10 times as large as what we experienced with the pandemic. Yet by 1948, federal outlays were \$29.8 billion and back to a little over 11% of GDP.

Since 1948, government has steadily grown, and spending as a percentage of GDP has more than doubled. That level far exceeds the size and scope of government the Founders envisioned. In 1930, prior to President Franklin Roosevelt's New Deal, <u>federal outlays</u> were 3.5% of GDP, while state and local expenditures were 9.1%. That was the foundational premise of America and the 10th Amendment—a limited federal government with most governing occurring close to the governed at the state and local level.

That vision of limited federal government is now unattainable, but returning to a reasonable prepandemic level of spending is doable. The economy is no longer forcibly shut down. Congress should at least be able to bring spending back to its 2019 share of GDP, which would total \$6.47 trillion next fiscal year. This would be \$838 billion below the CBO's current fiscal 2026 spending projection of \$7.29 trillion. Returning federal outlays to 20.6% of GDP would save \$8.4 trillion over 10 years. That's a lot better than the current paltry goal of \$1.5 trillion.

It's essential that Congress deviate from its current path. Under every scenario now being considered, federal debt continues to skyrocket from its current level of almost \$37 trillion. The CBO's current projection adds around \$22 trillion over the next 10 years, resulting in total debt of approximately \$59 trillion—134% of GDP—in 2035. That projection assumes an automatic tax increase will occur in 2026 when provisions of the 2017 tax cuts expire, increasing revenue from 17.1% of GDP in fiscal 2025 to an average of 18.1% over the next 10 years. With the CBO projecting 10-year GDP at \$373 trillion, that 1% increase represents \$3.7 trillion of additional revenue and lower debt.

No one can accurately predict the dynamic economic effects of changes in tax law, tariffs and the current trade war. But by repealing the automatic tax increase, adding \$1.5 trillion in additional tax cuts, pumping around \$340 billion into additional border and defense spending, and reducing other

spending by at most \$1.5 trillion, the One Big Beautiful Bill will almost certainly add to our deficits and debt. I doubt Mr. Trump's voters expect us to continue spending at President Biden's levels, which led to the inflation they elected Republicans last year to stop. I doubt, too, that Trump voters will be elated to see the GOP embrace Democratic policies and priorities—including ObamaCare, which seems to have found new life under the name "Medicaid expansion." And I can't imagine that they want Republicans to increase annual deficits. That's why I can't support this bill as it's currently being discussed and doubt that it will pass the Senate.

It's also why I'm asking the president and congressional leaders to reconsider a multistep strategy on budget reconciliation. By immediately passing a bill based on the Senate's original budget resolution, we can fund border security and defense priorities and bank \$850 billion in real spending reductions. The next step would be to pass a bill that extends current tax law to prevent the automatic 2026 tax increase, and avoids default by including a smaller increase in the debt ceiling that maintains the pressure and leverage to achieve future spending reductions.

With those goals achieved, sufficient incentive would remain to address President Trump's tax proposals focusing on working men and women and the already-expired business tax provisions of his 2017 tax law. It would also give us the time to simplify and rationalize the tax code, and go line by line through the entire federal budget to uncover, expose, and eliminate the hundreds of billions of dollars of waste, fraud, and abuse that the DOGE effort has shown exists. If we don't, America is headed off a cliff.

H.R. 22 - The Safeguard American Voter Eligibility (SAVE) Act

Radical progressive Democrats took drastic steps to fundamentally remake America through open borders and a full-scale assault on election integrity laws.

Rep. Chip Roy's SAVE Act (H.R.22) will address this by requiring proof of citizenship to register to vote in Federal elections to ensure the integrity of our elections. It amends the National Voter Registration Act (NVRA) to require states to verify US citizenship when registering an individual to vote in federal elections, give states the tools to remove non-citizens from their voter rolls, and penalize officials that knowingly register non-citizens.

MYTH: "The SAVE Act would prohibit married women - or anyone who has changed their name - from voting."

FACT: This is fake news. Under the SAVE Act, those individuals (i.e. most) who have updated their documentary proof of citizenship (which can include things like a REAL ID, passport, or government-issued identification with their place of birth), no action is needed, and they can register to vote. For the small fraction of individuals who have not yet updated their documentation to reflect a name change, which most do immediately for other life purposes, the SAVE Act explicitly directs states to establish a process for them to register to vote irrespective of those discrepancies. Like other areas of the law, citizens will be able to use combinations of existing identification documents, certificates of birth from the state, and other similar documentation to demonstrate citizenship. No one will be left unable to register to vote due to a name change.

MYTH: "The SAVE Act would require everyone to have a U.S. passport to register to vote."

<u>FACT</u>: The SAVE Act merely requires documentary proof of United States citizenship to register to vote. This is not just limited to passports, but can include: a REAL ID (in use in all 50 states now), a US military ID card together with paperwork showing place of birth was in the United States, and any valid government issued identification card issued by Federal, State, or Tribal government showing the applicants place of birth was in the U.S.

MYTH: "In federal elections, we have no evidence of illegals voting."

<u>FACT</u>: There is ample evidence of non-US citizens registering to vote. One <u>2014 study</u> of the 2008 and 2010 elections found that non-citizens voted and likely impacted the outcome in several races. Virginia <u>removed 1,481</u> voter registrations for "non-citizen status." In 2014, North Carolina <u>conducted</u> a study that found over 1,400 registered voters on its rolls appeared to be non-citizens. Numerous states and local jurisdictions are actively seeking to register non-citizens in their elections. One illegal ballot cast is one too many and can impact the outcome of tight elections.

MYTH: "The SAVE Act is unnecessary because it is already illegal for non-citizens to vote."

<u>FACT</u>: While only U.S. citizens can legally vote in Federal elections, the National Voter Registration Act (NVRA) effectively stops states from checking citizenship during registration, preventing the law from being enforced. The SAVE Act is needed to <u>require</u> states to verify US citizenship when registering individuals to vote in federal elections, give states the tools to remove non-citizens from their voter rolls, and penalize officials that register non-citizens.

MYTH: 'The SAVE Act will make it impossible for U.S. Servicemembers to vote if deployed aboard."

<u>FACT</u>: This bill does not amend the Uniformed Overseas Citizens Absentee Voting Act (UOCAVA) and leaves in place existing procedures and safeguards for servicemembers abroad to vote absentee in federal elections.

MYTH: "The SAVE Act is unconstitutional and violates the principles of federalism."

<u>FACT</u>: The Elections Clause, the Naturalization Clause, and the 15th, 19th, 24th, and 26th amendments clearly give Congress the authority to enact the SAVE Act. The SAVE Act is a narrow bill that simply strengthens the law that has governed the federal voter registration process for 30 years – the NVRA – by requiring states to verify citizenship for registration in federal elections.

A Message from State Representative Elijah Behnke

Dear Friends and Neighbors,

It's an honor to serve you as the Representative for the 6th Assembly District. Since being sworn in this January, I've been working diligently on your behalf in Madison while staying connected with our communities.

I'm pleased to report that the constitutional amendment requiring photo ID to vote, which I strongly supported through Assembly Joint Resolution 1, passed on the April ballot. This important measure ensures election integrity by requiring photo identification, just as is needed for many everyday activities.

In March, the Assembly passed a crucial legislative package protecting our children from harmful transgender policies. I proudly voted for the Help Not Harm Act prohibiting medical gender transitioning for minors, and the Save Women's Sports Act keeping males out of female sports and locker rooms.

I co-sponsored Assembly Bill 30 with Representative Pentermanand Senator Jacque to prohibit foreign adversaries from acquiring Wisconsin's agricultural and forestry lands, helping preserve our state's vital resources. This legislation would help protect our vital farmland from foreign ownership, which has nearly doubled nationwide over the past decade.

Between legislative duties, I've prioritized visiting schools and businesses across our



district. I recently toured Shawano Schools with Superintendent Kurt Krizan, and attended Grandparents Day at Gillett Elementary, recently recognized as a U.S. News Best Elementary School. I was also honored to attend the Suring Market & Agricultural Center Grand Opening, which will teach future generations essential farming skills through The David Reise Learning Center.

My priority remains listening to my constituents, and I continued to do so through listening sessions held in Pulaski, Clintonville, Bonduel, Shawano, and Cecil where we discussed crafting a responsible state budget that funds essential priorities while living within our means.

MEMORIAL DAY

As the session continues, my colleagues and I are continuing to put forth common sense legislation for Wisconsin. I am proud to be leading several of these bills.

In March, the Assembly passed two criminal justice bills I authored. Assembly Bill 66 prohibits prosecutors from dismissing or amending charges on several serious crimes without first obtaining court approval, including domestic abuse and sexual assault. AB 66 also prohibits prosecutors from giving criminals deferred prosecution agreements on these crimes, ensuring they do time behind bars. The Assembly also passed AB-85, which requires probation officers to recommend that criminals who violate conditions of probation be sent back to jail, ensuring that those who get second chances do not get third and fourth chances to stay on the streets.

In April, the Assembly passed another bill I authored to strengthen our unemployment system by requiring more meaningful work search requirements to continue receiving benefits and renaming the program to reemployment assistance to capture the true meaning of unemployment insurance, which is getting people off the system and back to work.

I am also proud to be a co-author of Assembly Bill 201, Bradyn's Law. AB-201 is named after Bradyn Bohn, a 15 year old high school student from my district who took his own life earlier this year after online criminals extorted money from him and threatened to release intimate photographs if he failed to send more. Stories like Bradyn's are increasing throughout the country. Bradyn's Law imposes stringent criminal penalties for this conduct including the possibility of felony murder charges. Bernie Sanders has been in Congress since 1991. 
